

TERMS AND CONDITIONS FOR VETERINARY PURCHASING "DAILY PHOTO CHALLENGE"

Your participation in Veterinary Purchasing's Daily Photo Challenge ("The Giveaway" or "Promotion") shall be deemed to be your complete acceptance of the Terms and Conditions herein. The following are the Terms and Conditions of The Giveaway:

1. Only persons over the age of 18 are eligible for entry to The Giveaway. You may be asked, at any stage, to provide Veterinary Purchasing or a third party with proof of age and /or identity.
2. No purchase or payment at any time is necessary to enter or win.
3. The Giveaway shall take place daily from March 2, 2022 to March 6, 2022.
4. The odds of being selected as a winner depend on the number of entries received. Each day, two winners will be randomly selected from the pool of entries for that day.
5. In order to enter the contest, the entrant must be a registrant of the OAVT 2022 Conference.
6. OAVT employees, sponsors, and affiliates' employees and their immediate family members are not eligible to participate.
7. Each entrant can make several entries into the Daily Photo Challenge only. In the event that Veterinary Purchasing deems an entrant to have acted in bad faith with respect to the Promotion, the entrant shall be excluded from the Daily Photo Challenge and consequently ineligible to win the Promotional Prize, as defined below.
8. The Prize for winning The Giveaway shall be one Indigo gift card.
9. Veterinary Purchasing shall notify the winner via E-mail within seven (7) of The Giveaway.
10. In order to claim The Prize, the winner must successfully answer a skill testing question.
11. The Promotional Prize will be delivered by mail.
